FIRELANDS FALCONS B.S.T INC. YOUTH SCHOLARSHIP APPLICATION

OVERVIEW

Firelands Falcons B.S.T. Inc. provides scholarships for registration fees to children, who without financial assistance would be unable to participate in the Firelands Hot Stove Baseball/Softball program. In certain cases the scholarship may also provide assistance for basic equipment required to participate in the program. Firelands Falcons B.S.T Inc. is a 501(c)(3) non-profit organization with limited funding available for scholarships. No guarantee of assistance is implied by this application. If the number of scholarship applications submitted and approved exceeds the dollar amount available, the scholarships will be awarded by a lottery system. Firelands Falcons B.S.T. Inc. does not discriminate on the basis of age, race, color, national origin, sex, religion, or disability in its programs and activities.

ELIGIBILITY

Requirements for eligibility:

- Athletes must be of eligible age to participate in the Firelands Hot Stove Program.
- Athletes must attend Firelands Elementary School, South Amherst Middle School or Firelands High School.
- Parents/Guardians must commit that the athlete will attend a minimum of 90% of all scheduled practices and games.
- The maximum amount awarded per recipient family is \$599.00 per calendar year (this is not a guaranteed received amount). Per IRS guidelines, Firelands Falcons B.S.T. Inc. is required to issue a 1099 to any individual or family that has received \$600.00 or more in funds or compensation in a calendar year.
- All Firelands Falcons B.S.T. Inc. board member's child(ren) are excluded from scholarship eligibility.

QUALIFICATIONS

Please provide all information required to help Firelands Falcons B.S.T. Inc. determine qualifications. Scholarship consideration will be given to families that meet the following criteria (All documents turned in minus the application and terms & conditions will be returned to the applicant after the consideration process):

- Provide a copy of the athlete's current report card from Firelands Elementary School, South Amherst Middle School or Firelands High School.
- Provide a copy of your IRS form 1040 from recent tax year (all information will remain confidential).
- Receive assistance from programs such as: Food Stamps, Medicaid, SSI, Foster Care, WIC, etc. and can provide written documentation of participation in these programs (all information will remain confidential).
- Provide a written statement of immediate financial hardship explaining the current situation.
 Firelands Falcons B.S.T. Inc. recognizes that a family may not be receiving formal assistance from
 the programs mentioned above, yet financial assistance may still be needed to participate in the
 Hot Stove Program. In these instances, the Firelands Falcons B.S.T. Inc. board will consider the
 financial hardship statement to determine scholarship eligibility. Please provide any supporting
 documentation that may support the facts in your financial hardship statement.
- Complete the application process and read and sign the Terms and Conditions statement.

FIRELANDS FALCONS B.S.T INC. YOUTH SCHOLARSHIP APPLICATION

PROCEDURE

Scholarship requests must be submitted to Firelands Falcons B.S.T. Inc. no later than February 28th in order to be considered.

A parent, guardian or head of household must complete the application, with all requested information provided. All items on the Scholarship Terms and Conditions must be initialed and the form must be signed and dated.

<u>Incomplete or late applications will be denied. If an application is incomplete you will not be</u> contacted requesting additional information.

As indicated above, all of the following must be included to be considered for scholarship:

- Athlete's current report card
- Income documentation (i.e. previous year tax returns, current paystubs)
- State or Federal assistance documentation
- Letter of hardship

The Firelands Falcons B.S.T. Inc. board will consider all scholarship applications completed with all necessary documentation and received by the deadline.

The amount of the scholarship awarded (if any) may be partial or full scholarship depending on the number of applicants, and amount of scholarship funds available.

The parent, guardian will be notified in writing either case of a scholarship being awarded or not.

Approval of a registration scholarship does not register the participant in the activity. A registration form and requested documents for registration must still be completed for the Firelands Falcons Hot Stove program for which the scholarship was rewarded.

Scholarship requests must be applied for annually.
